General

Weekly foot-passenger ticket	€ 10.00
Weekly student ticket (secondary, upper secondary school level)	€ 5.00

1. Trucks (unladen and unoccupied)*

Tariff D

1. Loads

 by weight, each 1,000 kg or part thereof	€ 0.50
by length if overhanging, per 1 m	€ 3.00

2. Animals

Horses, cattle, sheep, calves, pigs, lambs, piglets, etc. are only carried in vehicles. Calculated by weight as per section 1.

Special provisions

- a) **Excess width.** Widths in excess of 2.50 m, 20% surcharge on normal tariff.
- b) **Length calculation.** Unlisted vehicles or objects are calculated according to length: each metre or part thereof = €3.00.
- c) **Weekly tickets.** A weekly ticket may be purchased for motorcycles, motor cars (excluding motor caravans), delivery vans, courier vans and trucks up to 6 t max. permissible weight. The fare is seven times the individual fare for the vehicle and one person. The carriage charge for loads and additional persons is also to be paid.
- d) **Monthly billing according to ferry charge record.** The following reductions according to the ferry charge record will be granted for the carriage of vehicles over 6 t max. permissible weight listed under Tariff B, as well as their persons and loads:

for 16–20 journeys per month	15%
21–30 journeys	20%
more than 30 journeys	25%

The calendar month shall be authoritative. Prior agreement with the office is essential!

A charge of € 5.00 + VAT will be levied for invoices of less than € 50.00.

- e) **Special transportation.** Price by agreement.
